




Energy Efficiency Rating

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO₂ emissions, running costs and the savings possible from making improvements.

The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 65 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 4.4 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 1.8 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.

About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

2 Hot water cylinder insulation

Increasing the thickness of existing insulation by adding an 80 mm cylinder jacket around the hot water cylinder will help maintain the water at the required temperature; this will reduce the amount of energy used and lower fuel bills. The jacket should be fitted over the top of the existing foam insulation and over any thermostat clamped to the cylinder. Hot water pipes from the hot water cylinder should also be insulated, using pre-formed pipe insulation of up to 50 mm thickness, or to suit the space available, for as far as they can be accessed to reduce losses in summer. All these materials can be purchased from DIY stores and installed by a competent DIY enthusiast.

3 High heat retention storage heaters

Modern storage heaters have better insulation and are easier to control than the older type in this property. Ask for a quotation for new, high heat retention heaters with automatic charge and output controls. Installations should be in accordance with the current regulations covering electrical wiring. Ask the heating engineer to explain the options, which might also include switching to other forms of electric heating.

Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.

Your home's heat demand



1. INFORMATION AND SCOPE OF INSPECTION

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	Converted third floor flat contained within a Category A Listed mid terraced four storey and attic building consisting of a Public House at ground level and seven flatted dwellings above.
Accommodation	Third Floor: Entrance Hallway, Living/Dining Room, Kitchen, Two Bedrooms and Family Bathroom.
Gross internal floor area (m^2)	68 square metres of thereby.
Neighbourhood and location	The property is situated on commercial street in the city centre of Dundee. The surrounding properties in the immediate vicinity are generally of a comparable style and class consisting of tenement style blocks of flatted dwellings to the upper levels and commercial/retail premises at ground floor. The property is located within the local Conservation Area. A range of typical local amenities can be found nearby.
Age	150 years approximately.
Weather	Sunny and dry following generally similar conditions.
Chimney stacks	The chimney stacks appear to be of stone construction, pointed externally and support a range of clay pots. Our view has heavily restricted from ground level.
Roofing including roof space	The roof appears to be of pitched design being overlaid in slate and having a flat platform top section. Dormer windows are in place serving the uppermost properties. My view was severely restricted from ground level. Roof Space: This is a third floor flat with a property above and no roof space access was available.
Rainwater fittings	The gutters are primarily of concealed parapet style construction. Gutters and downpipes to the rear appear to be formed in cast iron and PVC.
Main walls	The building is of traditional sandstone wall construction with the walls having a dressed pointed finish and


	incorporating decorative features. The walls are lined internally and are approximately 0.7m thick.
Windows, external doors and joinery	<p>Double glazed timber framed window units are installed.</p> <p>The access door to the property is of timber panel design.</p> <p>Random windows were opened and closed where possible.</p>
External decorations	The windows and doors have painted finishes.
Conservatories/Porches	There are no conservatories or porches.
Communal areas	Access to the property is via a common hallway/stairwell. There is a lift within the block although this is not operational.
Garages and permanent outbuildings	There are no garages or permanent outbuildings.
Outside areas and boundaries	There are no private outside areas.
Ceilings	The ceilings are of plasterboard construction with some areas appearing to be formed in lath and plaster.
Internal walls	The internal walls and partitions are of lath/plaster construction and lightweight timber stud wall construction.
Floors including sub floors	<p>The floors are formed in suspended timber joists which appear to be overlaid in chipboard flooring.</p> <p>Sub-floor: No sub-floor inspection was available.</p>
Internal joinery and kitchen fittings	<p>The internal doors consist of timber panel units being fitted with moulded facing and surrounds.</p> <p>The kitchen is fitted with a range of base and wall units having compatible worktops and integrated appliances.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p>
Chimney breasts and fireplaces	The original fireplaces have been removed/blocked.
Internal decorations	<p>The internal walls and ceilings mostly have a painted finish.</p> <p>The internal joinery fittings are finished in paint.</p>
Cellars	There are no cellars.
Electricity	<p>There is no mains gas supply.</p> <p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were</p>

	<p>carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>
Gas	<p>Mains supply installed.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>
Water, plumbing and bathroom fittings	<p>The bathroom is fitted with a white suite. There is stainless steel sink unit and side drainer fitted within the kitchen. All visible pipework is made with copper and PVC materials.</p> <p>Visual inspection of the accessible pipework, water tanks, cylinders and fittings without removing any insulation.</p> <p>No tests whatsoever were carried out to the system or appliances.</p>
Heating and hot water	<p>Heating is provided by electric off peak storage heaters which are supplemented by electric instantaneous wall mounted heaters. Hot water is via an electric immersion fitted to the hot water cylinder located within a cupboard in the hallway.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p>
Drainage	<p>Drainage is connected to the main sewer.</p> <p>Neither drains nor drainage systems were tested.</p>
Fire, smoke and burglar alarms	<p>There is a provision of smoke alarms in the property.</p>
Any additional limits to inspection	<p>At the time of my inspection the property was occupied, fully furnished/heavily stored at parts and the floors were covered throughout. No roof space access was available. Externally, my inspection was severely restricted and conducted from a ground level only appraisal. My view of the roof slopes and pertinent was severely limited. No sub-floor access was available. In accordance with Health and Safety guidelines I have not disturbed insulation, furniture or personal effects (particularly in cupboards). Floor coverings have not been moved. I have not carried out an inspection for Japanese Knotweed and unless otherwise stated, for the</p>

purposes of the valuation I have assumed that there is no Japanese Knotweed or other invasive plants within the boundaries of the property or in neighbouring properties. The report does not include an asbestos inspection. However asbestos was widely used in the building industry until around 2000, when it became a banned substance. If the possibility of asbestos based products has been reported within the limitations of the inspection and you have concerns you should engage a qualified asbestos surveyor. Random testing for dampness was undertaken internally with the use of a moisture meter where accessible and considered appropriate. Parts of the property, which are covered, unexposed or inaccessible, cannot be guaranteed to be free from defect. **Only the subject flat and internal communal areas giving access to the flat were inspected.**

The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

Notes	<p>There is evidence of an ongoing roof leak within the living room and concealed timbers/components may be defective. Further investigation to be carried out by a firm of timber/damp specialist with a view to having all necessary remedial work implemented.</p> <p>There is evidence of condensation at parts. This may be alleviated by a proper balance of heating and ventilation. This should be monitored.</p>

Chimney stacks

Notes	Weathering was noted to the chimney stacks and the stonework. Regular ongoing maintenance should be anticipated to ensure water tightness.

Roofing including roof space

Notes	<p>There is evidence of a current roofing leak within the living room.</p> <p>A reputable roofing contractor can be asked to inspect the roof structure to advise on all necessary repairs to ensure wind and water tightness. Regular maintenance is anticipated until replacement.</p> <p>I am informed recent repairs to the roof have been carried out and any relating documentation should be retained.</p>

Rainwater fittings

Repair category:	2
Notes	<p>Weathering and staining were noted to the stonework around the parapet gutter. Parapet gutters require regular maintenance to avoid water ingress and damp/decay.</p> <p>The ceiling leak within the living room may be attributed to by parapet gutters.</p>

Notes	Weathering was noted to the stonework alongside staining from gutter leaks. If left unattended this can cause damage/rot.

Windows, external doors and joinery



Repair category:	2
Notes	A ruptured double glazed seal was noted which has caused condensation between the glass panes. Typical weathering was noted.

Notes	The renewal of paintwork should be anticipated at parts in due course.



The Surveyors are authorised to provide a transcript or retype of the generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by Brokers and Lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the generic Mortgage Valuation Report and the Single Survey. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

- the "Market Value" is *The estimated amount for which a property should exchange on the date of valuation between a willing buyer and a willing seller in an arm's-length transaction after proper marketing wherein the parties had each acted knowledgeably, prudently and without compulsion*
- the "Property" is the property which forms the subject of the Report;
- the "Purchaser" is the person (or persons) who enters into a contract to buy the Property from the Seller;
- a "prospective Purchaser" is anyone considering buying the Property.
- the "Report" is the report, of the kind described in Part 2 of these Terms and Conditions and in the form set out in part 1 of Schedule 1 of the Housing (Scotland) Act 2006 (Prescribed Documents) Regulations 2008;
- the "Seller" is/are the proprietor(s) of the Property;
- the "Surveyor" is the author of the Report on the Property; and
- the "Surveyors" are the firm or company of which the Surveyor is an employee, director, member or partner (unless the Surveyor is not an employee, director, member or partner, when the "Surveyors" means the Surveyor) whose details are set out at the head of the Report.
- the "Energy Report" is the advice given by the accredited Energy Company, based on information collected by the Surveyor during the Inspection, and also includes an Energy Performance Certificate, in a Government approved format.

PART 2 – DESCRIPTION OF THE REPORT

2.1 THE SERVICE

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by Statute and this is in the format of the accredited Energy Company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 THE INSPECTION

The Inspection is a general surface examination of those parts of the Property which are accessible: in other words, *visible and readily available for examination from*

ground and floor levels, without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the property.

The Inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Single Survey of properties that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a Register of Asbestos and effective Management Plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 THE REPORT

The Report will be prepared by the Surveyor who carried out the property inspection and will describe various aspects of the property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the property, will be concise and will be restricted to matters that could have a material effect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the property is free of any other minor defects.

Throughout the report, the following repair categories will be used to give an overall opinion of the state of repair and condition of the property.

- 2.3.1 Category 3: Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the property or cause a safety hazard. Estimates for repairs or replacement are needed now.
- 2.3.2 Category 2: Repairs or replacement requiring future attention, but estimates are still advised.
- 2.3.3 Category 1: No immediate action or repair is needed.

WARNING: If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the property. This is particularly true during slow market conditions when the effect can be considerable.

Parts of the property, which cannot be seen or accessed, will not be reported upon and this will be stated. If the Surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors.

2.4 SERVICES

Surveyors are not equipped or qualified to test the services and therefore no comment can be interpreted as implying that the design, installation and function of the services are in accordance/compliance with regulations, safety and efficiency expectations. However, comment is made where there is cause to suspect significant

defects or shortcomings with the installations. No tests are made of any services or appliances.

2.5 ACCESSIBILITY

A section is included to help identify the basic information interested parties need to know to decide whether to view a property.

2.6 ENERGY REPORT

A section is included that makes provision for an Energy Report, relative to the property. The Surveyor will collect physical data from the property and provide such data in a format required by an accredited Energy Company. The Surveyor cannot of course accept liability for any advice given by the Energy Company.

2.7 VALUATION AND CONVEYANCER ISSUES

The last section of the Report contains matters considered relevant to the Conveyancer (Solicitor). It also contains the Surveyor's opinion both of the market value of the property and of the re-instatement cost, as defined below.

"Market Value" *The estimated amount for which a property should exchange on the date of valuation between a willing buyer and a willing seller in an arm's-length transaction after proper marketing wherein the parties had each acted knowledgeably, prudently and without compulsion.* In arriving at the opinion of the Market Value the Surveyor also makes various standard assumptions covering, for example, vacant possession; tenure and other legal considerations; contamination and hazardous materials; the condition of un-inspected parts; the right to use mains services; and the exclusion of curtains, carpets etc. from the valuation. In the case of flats, the following further assumptions are made that:

- There are rights of access and exit over all communal roadways, corridors, stairways etc. and to use communal grounds, parking areas, and other facilities;
- There are no particularly troublesome or unusual legal restrictions;
- There is no current dispute between the occupiers of the flats or any outstanding claims or losses; and the costs of repairs to the building are shared among the co-proprietors on an equitable basis.

Any additional assumption, or any found not to apply, is reported.

"Re-instatement cost" *is an estimate for insurance purposes of the current cost of rebuilding the Property in its present form unless otherwise stated.* This includes the cost of rebuilding the garage and permanent outbuildings, site clearance and professional fees, but excludes VAT (except on the fees).

Sellers or prospective Purchasers may consider it prudent to instruct a re-inspection and revaluation after a period of 12 weeks (or sooner if appropriate) to reflect changing circumstances in the market and/or in the physical condition of the Property
